1. The selection will be made for the NHRIMII, Kottayam as indicated in the advertisement
2. The eligibility of the candidates will be determined as on the last date of receipt of application

The candidates who fulfil the eligibility requirement may apply in the prescribed format (Annex-1) along with the self attested photocopies of the testimonials of qualifications, experience, mark sheet, proof of date of birth, registration certificate 02 passport size photographs. Pension Payment Orders may also be attached., in case of retired personnel. Entries in the application form should be supported by the relevant documents

4. The candidates already in Govt. service must follow the prescribed procedure for applying through proper channel
5. The appointment will be made purely on contract basis initially for a period of one year
6. The candidates, if employed with any University/college/autonomous body/Govt. or private sector may bring NOC from their employer at the time of interview.
7. Application fee in the form of Demand Draft of Rs.250/-(Rupees five hundred fifty only) (non refundable) drawn in favour of "Director General, CCRH" payable at New Delhi should accompany the application. Applications received without the requisite fee will be summarily rejected. There will be no application fee for women candidates and candidates belonging to Scheduled Caste, Scheduled Tribe, Physically Handicapped and Ex-servicemen. Such candidates will have to submit along with the application form, requisite documentary proof in support of their belonging to one of the exempted categories.
